

Official Rules and Regulations

PRIZE WINNER WILL BE REQUIRED TO SIGN A WRITTEN AGREEMENT CONFIRMING THE ABOVE-DESCRIBED RELEASE AND WAIVER AS A CONDITION TO RECEIVING SUCH PRIZE(S).

Terms, Eligibility and Limitations

This raffle is a drawing by chance, sponsored by ST AUGUSTINE HEALTH MINISTRIES ("SAHM"). This raffle is only open to U.S. Residents at least 18 years of age, and is void where prohibited or restricted by law and is subject to all applicable federal, state and local laws and regulations. This raffle shall be governed by the laws of the State of Ohio. SAHM shall make all decisions related to the raffle in its sole discretion. By participating, you agree to be bound by these Official Rules and the decisions of SAHM and waive any right to claim ambiguity in the raffle operation or Official Rules. 1) ST AUGUSTINE HEALTH MINISTRIES is the official sponsor of the raffle.

2) By participating in the raffle, you agree to release and hold SAHM and its directors, officers, employees and agents, harmless from any and all losses, damages, rights, claims, and actions of any kind in connection with the raffle, including from your winning or use of any prize. SAHM makes no representations or warranties, expressed or implied, about the raffle or any prizes awarded.

3) Any or all of your entries will be disqualified at the sole discretion of SAHM if you attempt: (a) to enter the raffle through any means other than as described in these Official Rules; or (b) to disrupt the raffle, circumvent the terms and conditions of these Official Rules, or in any way tamper with the raffle. If either of the above occurs, SAHM has the right to remedy any such action, disruption, or circumvention, and to seek damages from you to the fullest extent permitted by law.

4) SAHM is not responsible for error, omission, interruptions, deletion, defect, delay in operations, theft or destruction or unauthorized access to or alterations of entry materials, or for malfunctions of any kind, or inaccurate or failure to receive entry information or any combination thereof. SAHM is not responsible for any entries that are late, misdirected, incomplete, or altered. SAHM reserves the right to cancel the raffle if the registration process and/or raffle become corrupted or fail of their essential purpose.

5) SAHM employees, volunteers and board members are eligible to enter contest and win the Raffle.

6) If, for any reason, the administration, security, fairness or integrity of the Raffle has been compromised, SAHM reserves the right, exercisable at its own discretion, to cancel, terminate, modify or suspend the Raffle and refund all proceeds. The official rules may be amended by SAHM in its sole discretion.

7) At SAHM's sole discretion and option, the date for the drawing may be extended by no more than thirty (30) days.

8) The IRS has taken the position that amounts donated for chances to participate in raffles, lotteries or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution.

9) An individual can purchase as many tickets as he or she may wish, subject to availability.

Tickets

Single tickets are \$10 each or three (3) for \$25 or (6) for \$40 at the time of sale. Only one method of payment, one name, and one mailing address are permitted per ticket or ticket pack. Only one eligible person may be entered in the raffle per ticket sold. Available tickets may be purchased until Friday, April 27 at 8:30 p.m.. The winners will be chosen by random drawing from the pool of all entrants on Friday, April 27, 2018 at 9pm at ST AUGUSTINE HEALTH MINISTRIES and will be announced at that time.

Odds of Winning

The odds of winning a prize will depend on the number of tickets sold.

How to Purchase

ST AUGUSTINE HEALTH MINISTRIES assumes no responsibility for lost, late, misdirected or non-delivered mail or fax messages, or any other failure to purchase a ticket prior to the drawing deadlines.

Prize

For the purposes of this raffle, the prize is a travel voucher valued at \$2,000. Voucher must be redeemed with Canary Travel, to be considered valid. 1 total prize will be awarded. The travel voucher must be redeemed with Canary Travel and travel completed within one (1) calendar year of ST AUGUSTINE HEALTH MINISTRIES's purchase date (March 15, 2018) or Raffle Prize Winner forfeits the Prize Package in its entirety.

Per Canary Travel, trip must be booked at least sixty (60) days prior to departure and is subject to availability and blackout dates. Drawing will be held on April 27, 2018 from all eligible raffle tickets. Only official raffle drawing tickets will be drawn. Winner need not be present to win. Winners will be notified according to the contact information provided to ST AUGUSTINE HEALTH MINISTRIES at the time of ticket purchase.

1) If the name of more than one person is submitted with a ticket and that ticket is selected as a winning ticket, then the person named first so long as that person is 18 years old and a U.S. resident will be deemed the holder of record of that ticket and declared the winner.
